

Summer in The Swamp

BOONTON HILLS & VALLEY LACROSSE WAIVER AND RELEASE OF LIABILITY FOR MINOR PARTICIPANTS

IN CONSIDERATION OF MY CHILD _____, being allowed to participate in the Summer at the Swamp Clinic (hereinafter "Clinic") held on Wednesdays from June 20, 2018 through July 25, 2018, the undersigned understands and agrees to the following:

1. The undersigned hereby releases, waives, discharges and covenants not to sue Boonton Hills & Valley Lacrosse, its officers, servants, coaches, agents and employees (hereinafter referred to as "Releasees") from any and all liability, claims, demands, actions and causes of actions whatsoever arising out of or relating to any loss, damage or injury including death that may be sustained by my child or to any property belonging to my child caused by the negligence of the Releasees or otherwise, or participating in the Clinic or while in, on or about the Premises where the Clinic is being conducted, or otherwise to the full extent permitted by New Jersey Law.
2. I understand that lacrosse involves certain risks, including, but not limited to, death, serious neck and spinal injuries resulting in complete or partial paralysis, brain damage, and serious injury to virtually all bones, joints, muscles, and internal organs and that equipment used by my child for protection may be inadequate to prevent serious injury. I am voluntarily allowing my child to participate in this activity with the knowledge of the danger involved and hereby agree to accept any and all inherent risks of property damage, personal injury or death. I further certify that my child is in good health and able to participate in lacrosse activities.
3. I, my spouse, and my child knowingly, freely and voluntarily assume full responsibility of any risk of loss, property damage or personal injury, including death that may be sustained by my child, or any loss or damage to property owned by me and/or my child, as a result of my child being participant in the Clinic, whether caused by the negligence of the Releasees or otherwise.
4. It is my express intent that this Release of Liability, Hold Harmless Agreement, and Assumption of Risk shall bind me, my spouse, and my child, if we are alive and our heirs and assigns to personal representatives, if we are deceased and shall be deemed as a Release, Waiver, Discharge, Covenant to not sue the above Lessees.
